LOCATION

The subject property fronts Bank Street, close to its junctions with Bradshawgate and Deansgate, within Bolton Town Centre. Car parking is close by and there is easy access to the surrounding road network. There is a mixture of operators nearby including pubs, estate agents and food uses.

The property is well connected, with Bolton Railway Station located within close proximity, offering regular services to Manchester and surrounding areas. In addition, the location provides convenient access to the A666 (St Peter's Way), which connects directly to the M60 and M61 motorway networks, ensuring excellent regional and national connectivity.

DESCRIPTION

The subject property comprises a traditionally constructed 3 storey Town centre retail property. Internally, the accommodation is arranged over ground, first and second floor levels, providing for majority open-plan accommodation. There is further ancillary basement accommodation, which isn't suitable for anything other than basic stores. There is a traditional style double fronted shop display window. The property may suit a variety of uses STPP and has previously been a bridal shop before its later use as a bar.
